President Diamantis welcomed senators to the new academic year 2017-2018. She also thanked President Bertolino for providing lunch for the meeting.

Senator Faraclas (PCH) moved to change the orders of the day and bring new business before the Senate. Motion seconded and approved unanimously.

New Business

President Diamantis provided background of the actions that were taken during the summer to conform to the new CBAC agreement.

Senator Stuzman (PT) moved to ratify actions taken during the Summer of 2017 by Faculty Senate President Diamantis to modify language in the Renewal, Promotion and Tenure, Professional Assessment, Sabbatical, and Retraining documents in order to comply with the current Collective Bargaining Agreement. Motion seconded and approved unanimously.

Senator Abdelsayed (ACT) moved to accept the Faculty Senate Resolution on Necessary Modifications of the Faculty Senate Promotion and Tenure Procedures Document (2017-2018) regarding the Evaluative Category of "Record of Disciplinary Action." Motion seconded. After discussion, Senator Faraclas (PCH) moved to delete "2017-2018" from the language of the document. Motion seconded. After debate, the amendment was approved. Guests

President Diamantis welcomed Southern Connecticut State University President Joe Bertolino to speak.

University President Bertolino

- Thanked Senators for their attendance at Convocation as well as all of the beginning-of-thesemester events.
- Welcomed Provost and Vice-President of Academic Affairs Dr. Robert S. Prezant.
- Welcomed ACE Fellow Dr. Erin Webster-Garett, who will be shadowing him this year.
- Reaffirmed his vision of Southern as an institution that champions social justice. Offered
 advice on how to help students in crisis, especially with the current debate on the DACA
 program. Please refer them to the office of Dr. Tracy Tyree, Vice President of Student
 Affairs.
- Clarified that the discussion at the School of Arts & Sciences meeting concerning the division of the school was premature. Affirmed his commitment to transparency in his administration and stated that before any decision is made, a lengthy conversation needs to take place.

- O Senators offered questions concerning possible future steps, including faculty fora or a special committee to assess the financial benefits or drawbacks.
- Shared that enrollment currently stands at 10,406, which is nearly stable and thus a positive in our current environment. Stated that we need to work on our retention and would like to aim for at least a 1% improvement in retention per year. Shared that the "word on the street" about Southern is positive, and that a lot of work is being done to bring in new donors to the University.

Senator Faraclas (PCH) shared his concerns on summer committee work without pay, stating that

Faculty Senate Resolution on Necessary Modifications of the Faculty Senate Promotion and Tenure Procedures Document regarding the Evaluative Category of "Record of Disciplinary Action"

Whereas, Southern Connecticut State University (SCSU) exists for the primary purpose of furthering academic excellence;

Whereas, The SCSU Faculty Senate is the official representative body of the Academic Faculty;

Whereas, The 2016-2021 Collective Bargaining Agreement includes a new evaluative category, namely "Record of Disciplinary Action";

Whereas, The Faculty Senate Promotion and Tenure Procedures document needs to be consistent with the evaluative categories set forth in the CBA;

Whereas, The Faculty Senate Promotion and Tenure Procedures include a weighted value and scoring scale for each category; and

Whereas, The new evaluative category "Record of Disciplinary Action" is the lowest weighted category; now, therefore, be it

Resolved, That the following sections of the P&T Senate document be modified as follows:

- I. In PART III -- STRUCTURE AND PROCEDURES, H. University Promotion and Tenure Files, 1. Contents of the File, a. Candidate's Responsibility, the following item shall be added as #10 of a list of items the candidate is required to include in his or her file: "10. Any record of disciplinary action currently in the candidate's personnel file that is not scheduled to be removed prior to the end of the review process."
- II. In PART IV -- PROCEDURES OF THE PROMOTION AND TENURE COMMITTEE, A. Promotion, 3., the following phrase shall be inserted as indicated in the paragraph immediately below: "and except for category 6 where each Committee member shall assign the candidate a number on an eleven-point rating scale (0-10)."
- "3. After discussion and deliberation on a given candidate are completed, each Committee member shall assign the candidate an integer on a ten-point rating scale for each evaluation category, except for category 5 where 1 point is given for every year of service beyond five years up to a maximum of 15 points, and except for category 6 where each Committee member shall assign the candidate a number on an eleven-point rating scale (0-10). (See Part IV., C. below). The integers should measure, as accurately as possible, the candidate's performance in each of the evaluative categories."
- III. In PART IV -- PROCEDURES OF THE PROMOTION AND TENURE COMMITTEE, C. Computing and Interpreting Ballots, 3. The total of these weighted averages shall be computed as follows, the following line in this section shall be modified as follows:
- "Record of Disciplinary Action-----average is multiplied by -1"
