

President's Report to the Faculty Senate – March 25, 2015

- 1. The University Budget and Planning Committee (BPC) by-laws specify representation by "six full-time members of the Instructional Faculty, four elected by the Faculty at large and two elected from and by the Faculty Senate." The four at-large representatives are: Dr. Karen Burke (MDS), Dr. Ross Gingrich (MAT), Dr. Patrick Heidkamp (GEO) and Dr. Patricia Kahlbaugh (PSY). The two elected Senators are Dr. Peter Madonia (EDL) and Dr. Michael Shea (ENG), who were appointed several years ago. The FS has neither a specified election process nor term of office for the two Senate BPC representatives.
 - a. I recommend the FS affirm the terms of Senators Madonia and Shea for the rest of this year.
 - b. The FS Rules Committee has been asked to recommend an election process for the future.
- 2. Reminder: Faculty Dialogue (*Defining "Teacher-Scholar": Exploring Faculty Workload and Life Balance*), is tomorrow, March 26, 2015, 12:30-2:00 PM, in **EN B121**.
- 3. The Student Advisory Committee to the BOR will host a System-wide Media Event ("What's It Gonna Cost CT") to show support for CSCU and appeal to legislators to increase funding for public higher education. Details: Thursday, March 26, 2015, 12:30 PM, at Capital Community College (in Degnan Hall, Room 1126, 950 Main St, Hartford, CT 06103). [Note: this event unfortunately conflicts with our Faculty Dialogue. Those not attending the Dialogue should consider attending the media event.]
- 4. Southern's first Undergraduate Research and Creative Activity Conference will be held on Saturday, March 28, 2015, from 8:00 AM to 5:00 PM in the Adanti Student Center Ballroom. Presentations from 125 students will showcase academic excellence, highlighting the breadth, depth and quality of student-faculty projects that are possible in a University that values teaching and creative activity. Students and their families will be in attendance, along with applicants considering attending SCSU next year. The BOR, legislators and the media have been invited. (The conference is free, and it includes breakfast, lunch, and an art show.)
- 5. The Faculty Senate Executive Committee will be meeting with the Provost's Council on April 1, 2015, along with the Faculty Leadership Council.
- 6. April 2, 2015, luncheon for tenure-track faculty members hired in the past three years, *Shared Governance, Balancing Expectations, Becoming Engaged: A Conversation with Newly Hired Faculty:* space-available invitations extended to 4th- and 5th-year members.
