

FACULTY SENATE

President's Report to the Faculty Senate – February 24, 2016

- 1. Planning has begun for the New Faculty Workshop, a date for which is still being determined. The *ad hoc* planning committee, including Dr. Barbara Cook (CMD), Dr. Aaron Clark (MAT), Dr. William Faraclas (PCH), Dr. Joseph Fields (MAT), Dr. Sanja Grubacic (ECO/FIN), Dr. David Pettigrew (PHI) and Dr. Deborah Weiss (CMD), met on Tuesday, February 23, 2016. The workshop will focus on teaching faculty members in their first three years on tenure-track, but will be open to all pre-tenure members.
- 2. **The Faculty Senate Forum on Judaism also is being planned.** Chaired by Dr. Deborah Weiss (CMD), the ad hoc planning committee membership is Dr. Michele Abrams (CMD), Dr. Corinne Blackmer (ENG, JST), Dr. Martin Laskin (SOC), Dr. David Levine (ART, JST), Dr. David Pettigrew (PHI), Dr. Deborah Savage (ECO) and Mr. Walter Stutzman (MUS). - 3. Special Act 14-11 An Act Concerning a Plan for Participation in a *State Authorization Reciprocity***Agreement [SARA] Regarding Distance Learning Programs. The CT General Assembly is considering a bill that would charge the Office of Higher Education (OHE) with developing a plan to establish authorization reciprocity with other states for the delivery of online instruction.

In a 2015 brief¹ on ensuring educational integrity, specifically regarding state oversight of for profitschools, the National Consumer Law Center wrote:

"Distance online education is now the fastest growing segment of higher education. Most states, however, have abdicated their responsibility to protect the increasing number of online education students from predatory and illegal practices of for-profit education companies. Most allow out-of-state companies to enroll online students without complying with important state consumer protections for postsecondary students, as long as the companies have no physical presence in state. These states either exempt these schools from oversight or have signed weak state authorization reciprocity agreements that prevent state enactment or enforcement of postsecondary education consumer protection laws."

In a 2015 Legislative Report² on SA 14-11, the CT Office of Higher Education recommended that Connecticut not join SARA. Among its concerns:

- "It would lead to a two-tiered approval system that could mislead and harm students.
- It would require that Connecticut relinquish its ability to review for-profit [Institutions of Higher Education (IHEs)] for academic quality and student protections.
- It would significantly increase the number of IHEs operating in the state, potentially decreasing enrollment at the state's public colleges and universities and smaller independent institutions.
- It would undermine the assurances of academic quality by allowing for IHEs with national accreditation, which meet lower approval standards than required for regional accreditation.
- It would place Connecticut IHEs at a competitive disadvantage because they will be held to more rigorous regional accreditation and state academic standards than those from out-of-state."

On Thursday, February 25, in response to a request from the SCSU-AAUP, a group of Southern faculty members, including Dr. Barbara Aronson (NUR), Dr. William Faraclas (PCH), Dr. Elizabeth

Dr. Elena Tapia (ECSU), CSU-AAUP Vice President, is now serving as Chief Negotiator for the faculty. Our very best wishes are with Vijay, who has done a wonderful job, and with Elena, who will provide strong leadership.
