## President's Report to the Faculty Senate – April 27, 2016

Southern Connecticut State University

- Attendance/Participation Reporting for Financial Aid Eligibility. Following the April 14, 2016, forum, a committee was formed to develop a policy recommendation for monitoring student participation in courses. The FS appointed four faculty members to sit on the committee: Dr. Jane McGinn (COM), Dr. David Pettigrew (PHI), Dr. Elizabeth Rhoades (CSP), and Mr. Walter Stutzman (MUS/FYE).
- 2. Newer Faculty Workshop. Twenty-eight untenured faculty members attended the workshop, and heard presentations from 15 tenured members and three pre-tenure colleagues. Topics discussed included academic freedom, shared governance, campus culture, faculty unity, balancing roles and responsibilities, and specific concerns of untenured members. The Faculty Senate gives its thanks to the Workshop planning committee: Dr. Aaron Clark (MAT), Dr. Barbara Cook (CMD), Dr. Joseph Fields, (MAT), Dr. Sanja Grubacic (ECO/FIN), Dr. David Pettigrew (PHI), Dr. Deborah Weiss (CMD), and Dr. William Faraclas (PCH).
- 3. End-of-Year Faculty Retreat. Co-sponsored by the Faculty Senate and SCSU-AAUP, this year's retreat for all members of the faculty will take place on \_\_\_\_\_\_, May \_\_\_\_\_, 2016, at 10:30 AM-2:30 PM. Place: Savin Rock Conference Center, 6 Rock Street, West Haven, CT 06516
- 4. Workflow Group: SSC Campus Platform for Academic Advisement. The Workflow Group, which is working on an enhanced advising platform that will be launched in the fall, would like to add a faculty member to its ranks through selection by the Faculty Senate.
- 5. **Resolution on CSCU Provost Selection.** A resolution regarding the selection of a new system Provost was passed by the Community College Governance Assembly on April 15 and subsequently endorsed by the Faculty Advisory Committee to the BOR. It was requested by the FAC that each campus governance body consider the resolution for endorsement or approval. The resolution reads:

"Student success through academic excellence is highlighted in the Connecticut State Colleges and Universities Vision Statement. With the retirement of Dr. Estela Lopez as the Interim Academic Provost the Community College Governance Assembly believes the priority of the Board of Regents should be to initiate a search for a permanent, qualified Academic Provost as soon as possible."

In the same spirit of consultation that we request from campus and system Administrations, I contacted President Mark Ojakian's office to review the existence of the resolution and the call for campuses to endorse it, and to ascertain President Ojakian's current thinking on the search for a CSCU Provost. In communications with Chief of Staff Alice Pritchard I stated the argument for conducting a national search for a permanent Provost, with an interim Provost serving only until a search could be completed, and, noting the role of the Provost as chief academic officer, stated the importance of inclusion of faculty representatives on a search committee. Today, COS Pritchard informed me that President Ojakian has decided to search for a permanent Provost using internal posting to draw upon talent within the system. She wrote that "[President Ojakian] confirmed the plan is to have faculty input through a FAC session with candidate(s) before a final selection of provost is made by the President."
