President's Report to the Faculty Senate - November 30, 2016

 The Newtown screening event took place on Thursday, 11/10 at 7-10 pm at Lyman Hall with 850 attendees. - 2. The Faculty Leadership Council met with President Bertolino and Provost Durnin on Thursday November 15 and addressed the issue of reassigned time distribution (10.6.5). More information will be forthcoming on this issue to make the process more equitable and transparent.
- 3. President Bertolino met with the FS Executive committee on November 17 and discussed the following items:
 - a. Some budget update 10% decrease from state appropriations and the request from BOR on reserve funds; possible tuition increase; and personnel cuts are also possible.
 - b. Science building has some unfinished plumbing, electrical, and other issues unresolved.
 - c. Some support for the Instructional Technology Director's position is needed.
 - d. Invitation to President Joe and Mark Rozewski to attend the FASP committee.
 - e. Request to consider looking into the two P&T denials from last year, with the four specified categories and the weight for each through the department, chair, and dean's letters.
 - f. A suggestion was made that a Town Hall meeting is scheduled to discuss the Branding and Marketing Survey findings as well as the next steps. Possible date: Friday, December 9 Reading day.
- 4. President Bertolino held his second University Dialogue on November 21 and highlighted issues such as the latest launch of advertisement videos about SCSU that are showing up on local television and radio stations; the video on Social Justice week's events created by our students; he thanked Student Affairs office on the success of Social Justice week's events; and he thanked the committee chairs for the Newtown Screening event that initiated the Social Justice week's events, William Faraclas and Maria Diamantis. Question from the floor on the budget update, not much information is available. But as recent as yesterday, there is an emergency meeting for the budget this Monday, December 5. The FS Executive committee members were invited along with the FLC.
